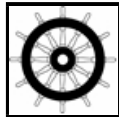

Application/Limitation

Approved for use as low flame spread material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as floor coverings on any metallic base or non-combustible base.

Approved colour: white
Maximum organic content: 40%
